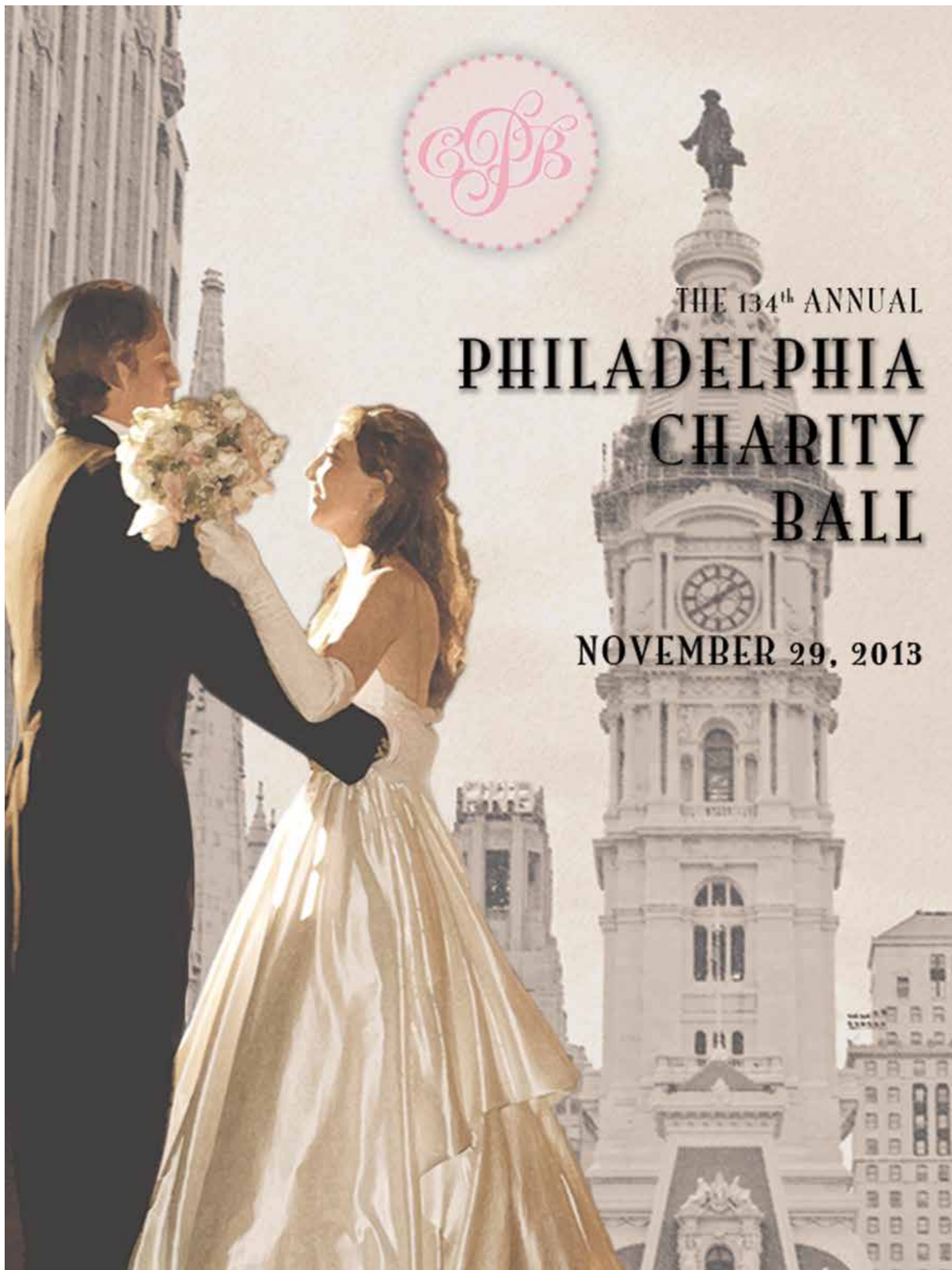

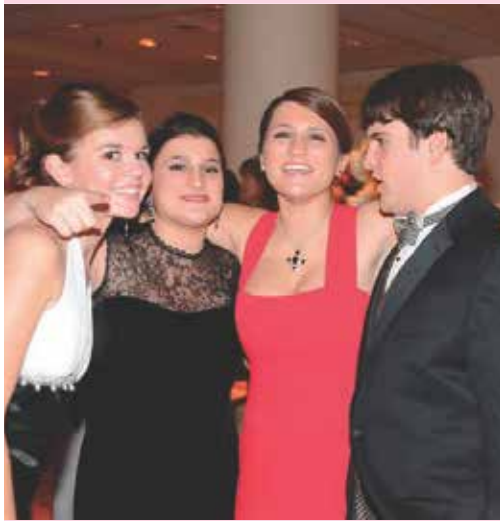
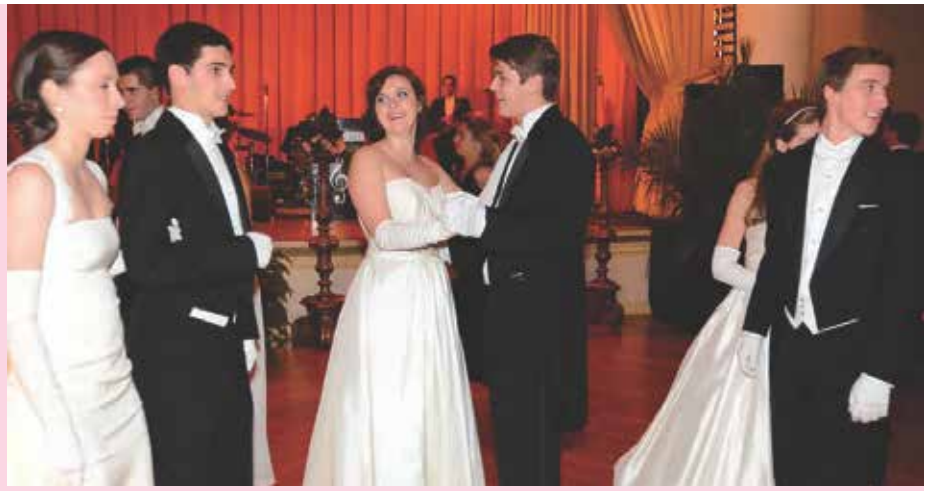


Miss Rebekka Suzanne Rueda
