

His community involvement included working at his church, St. Paul's in Exton, and volunteering as a student center for underprivileged children at a school in Connecticut.


Hugh loves to travel. He has been to Iceland, Denmark, Sweden, France, Italy, Germany, Holland, Belgium, and England.
