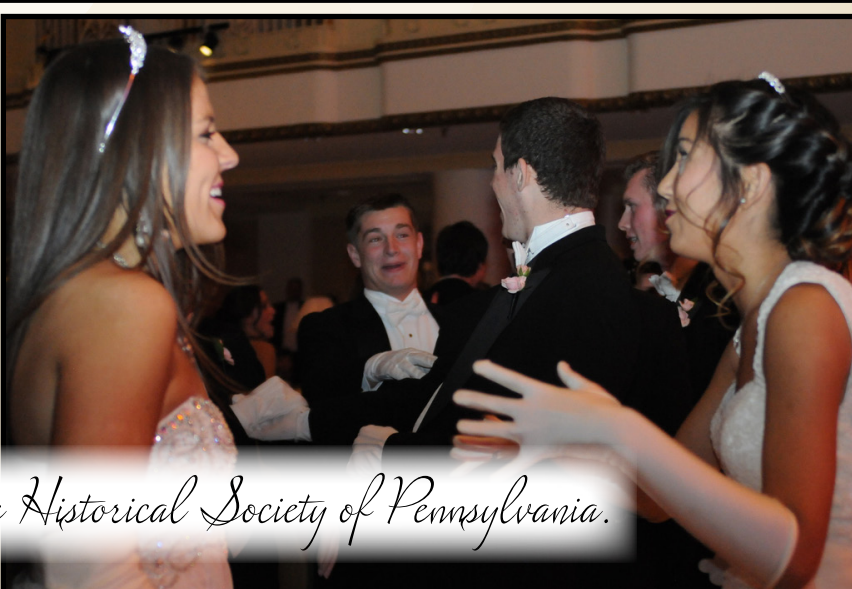

Camilla looks forward to her first year on Marist's main campus and wishes to study abroad in Paris her Junior year to learn more about other cultures.



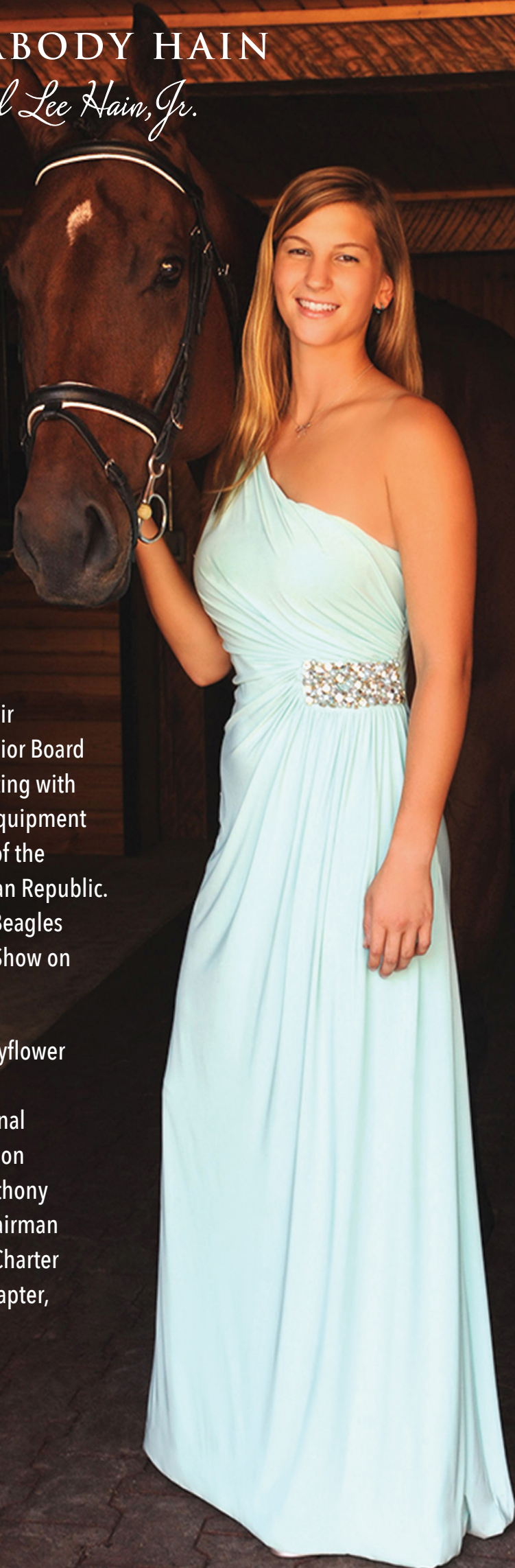
MISS VICTORIA PEABODY HAIN
